
5. Total No. of BYES given are Five (5). Two (2) in Group A and Three (3) in Group B.

3. **MOST IMPORTANTLY, ALL THE PARTICIPATING PLAYERS SHALL CARRY 1 CARDS ISSUED BY THEIR RESPECTIVE DEPARTMENTS (PRESENT), IN-ORIGINAL, WITH THEM DURING THE MATCHES AND BEFORE START OF THE MATCH CAPTAINS OF BOTH THE TEAMS SHALL HAND OVER A PHOTO COPY OF THESE 1 CARDS OF THE PLAYING ELEVEN TO THEIR RESPECTIVE TEAMS TO THE IN CHARGE OF THE GROUND, WHERE THE MATCH WILL BE PLAYED, WHO WILL ALSO BE THE MATCH REFEREE. ALSO, ONLY THOSE OFFICIALS ARE ELIGIBLE AND ALLOWED TO PARTICIPATE IN THE MATCHES WHO ARE PHYSICALLY WORKING (IN ANY CAPACITY) WITH THE DEPARTMENTS IN THE PREMISES OF DELHI SECRETARIAT. ANY OFFICIAL/PLAYER WHO DOES NOT MEET THIS CRITERION WILL BE DEBARRED FROM PARTICIPATING IN SAID MATCH OR MATCHES.**
