

Subject:- Organisation of Inter-Departmental Sports Tournament 2023-24 -
regarding schedule and other information of Badminton matches.

The information with regards to conduct of badminton tournament is as under:-

1. The matches are scheduled to be held **w.e.f. 11th July, 2023 at 9:00 am onwards at Thyagraj Stadium near INA, Delhi except the matches of officers in the age group of 50-60 years.**
2. The matches of officers in the **age group of 50-60 years will be held at Ludlow Castle Sports Complex, Sham Nath Marg, Delhi - 110054.**
The dates and timings of the same will be intimated in due course.
3. The fixtures will be made available on the official website of General Administration Department, Govt. of NCT of Delhi **on 10th July 2023 at 3.00pm.**
4. All the participants are requested to go through the fixtures thoroughly and report for their matches accordingly on the scheduled date and time.
5. All players are required to participate in proper dress code meant for Badminton discipline.
6. All the matches upto pre-quarter final stage will be played with the plastic shuttlecocks, preferably Mavis 350 brand which will be provided by General Administration Department.
7. All the matches from quarter finals onwards will be played with feather shuttlecock which will be provided by General Administration Department.
8. All the matches upto pre-quarter finals will comprise of set of 15 points each and best of three sets.
9. All the matches from quarter finals onwards will comprise of set of 21 points each and best of 3 sets.
10. The players are required to bring their own racquets, shoes etc. at their own cost to participate in these games. It is mandatory to wear **non-marking** badminton shoes to enter the courts.



11. It is mandatory to produce original official Id proof before the start of the match.
12. The decision of the Tournament Committee will be final on all points of facts. The Chief Referee will be the sole in-charge of all technical issues on point of law.
13. Every player has to report at least 30 minutes before the scheduled time of the match, otherwise walkover will be given to the opponent.
14. The decision of General Administration Department will be final and binding upon all the players and Departments.
15. No food or eatables are allowed inside the arena before and after the match.
16. Since the summer season is at peak in the month of July; so the players are advised to get themselves medically checked and ensure that they are fit to participate in Badminton events. If needed, they should carry their own energy drink or any other glucose water for hydration.
