The probable players are hereby directed to attend the practice session on every Friday after lunch and on every Saturday (10.00 A.M. onwards) at Rajiv Gandhi Sports Complex, Bawana, Delhi till the date of AICS tournament.

The probable players are also allowed to attend the practice session on 1<sup>st</sup> & 3<sup>rd</sup> Wednesday of every month at Wrestling Complex, Chhatrasal Stadium, Delhi (10.00 AM onwards) for receiving specialized coaching/tips from the expert coaches of Chhatrasal Stadium, till the date of AICS Tournament.

The members of the Wrestling probable team shall be treated as "on duty" during the practice session. The players are informed that their punctuality during the practice session shall also be considered for final selection in the team for All India Civil Services Tournament. **Unauthorized absence from the practice shall be viewed seriously.**


The selected players shall submit the permission of the concerned Head of Department/Competent Authority for participation in the practice camp and the AICS Tournament in the prescribed proforma. This permission performa is to be submitted in this office within 07 working days of the issuance of this order, failing which his/her selection shall be cancelled without any notice. One player can participate as a probable player in only one game/event, failing which suitable action shall be taken against the concerned player as per rules.


