Further, it is also requested that all the officers/officials presently working in your department may be directed to report for trial. The trials shall be made strictly on the basis of instructions issued by the Central Civil Services and Sports Board, Government of India. As per the existing instructions, the following categories of employees are not eligible for participation;

- i. *Employees of Autonomous bodies/Undertaking/Public Sector Banks even though administratively controlled by the Central Ministries.*
- ii. *In case of Deputation – The status of the Organisation in which the person is working on deputation or otherwise is to be taken into account for deciding the eligibility.*


On selection as probable player, it is directed to submit the permission of the concerned Head of Department/competent authority for participation in the practice camp. This permission performa/letter will be required to be submitted within 10 working days of the issuance of selection order, failing which next player in the merit will be considered for selection as probable player. The performa will be available on the website of this department.


