The selected players shall submit the permission of the concerned Head of Department/Competent Authority for participation in the practice camp and the AICS Tournament in the prescribed proforma. This permission proforma is to be submitted in this office within 07 working days of the issuance of this order, failing which his/her selection shall be cancelled without any notice.


The members of the probable team shall be treated as "on duty" during the practice session and no compensatory leave shall be allowed to the players. The players are informed that their punctuality during the practice session shall also be considered for final selection in the team for All India Civil Services Tournament. Unauthorized absence from the practice shall be viewed seriously.

If any probable player is deployed with any election related duty he/she shall not proceed to the said practice session/ tournament without approval of concerned DEO/RO/any concerned Election agency. Preference will be given to election duty rather than the sports tournament.

Sh.Sanjay Kumar Sharma, Grade-I, DSW, GNCTD and Sh.Rambir, ASO, Sports Branch, DoE are appointed as Incharge and Coach of the probable players of Football team for the year 2024-25.
