Sub:- Selection trial of players for Delhi & District Cricket Association (DDCA) League Season 2024-25.

It is informed that the trial for selection of players for Delhi & District Cricket Association (DDCA) League Season 2024-25, have been scheduled as under:-

The trials shall be made strictly on the basis of instructions issued by the Central Civil Services and Sports Board, Government of India. As per the existing instructions, the following categories of employees are not eligible for participation;

- i. *Employees of Autonomous bodies/Undertaking/Public Sector Banks even though administratively controlled by the Central Ministries.*
- ii. *In case of Deputation – The status of the Organisation in which the persons is working on deputation or otherwise is to be taken into account for deciding the eligibility.*

On selection as player, he is required to submit the permission of the concerned Head of Department/Competent Authority for participation in the practice camp. This permission performa/letter will be required to be submitted within 10 working days of the issuance of selection order, failing which next player in the merit will be considered for selection as probable player. The said performa is also available on the official website of this department.

Further, if any probable player is deployed with any election related duty he/she shall not proceed to the said trial without approval of concerned DEO/RO/any concerned Election agency.

All Head of Departments, Govt. of NCT of Delhi are requested to circulate this trial schedule among all the officers/officials working in their departments. Interested officers/officials may also be allowed to report for trials at the venue as per schedule.
