The Tug-of-War matches are scheduled to be held w.e.f. **14th July, 2023** onwards at Thyagraj Stadium, near INA, New Delhi.



The other information with regards to conduct of the matches is as follows:

1. The team will comprise of 10 players each. However only 8 players will play at a time.
2. Maximum combined weight for 8 players in men category will be 680 kg.
3. Maximum combined weight for 8 players in women category will be 560 kg.
4. The players are allowed to participate in general sports shoes without spikes.
5. The matches will be played on league basis instead of Knock out basis as earlier communicated.
6. The match will be decided on best of three pull each.
7. The decision of the Tournament Committee will be final on all points of facts. The Umpire will be the sole in-charge of all technical issues on point of law.
8. All the above teams are required to report on **14.07.2023 (Friday) at 6.00pm at Thyagraj Stadium, near INA, New Delhi.**
9. The decision of General Administration Department will be final and binding upon all the players and Departments.


