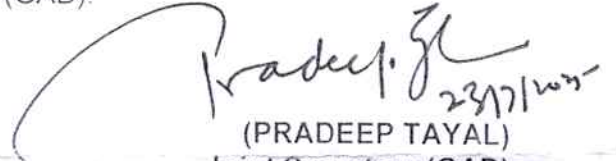
ORDER

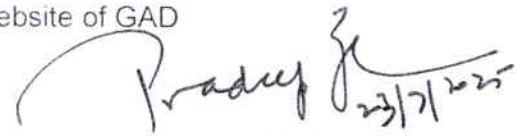
