If the participating vendors or their authorized representative wish to attend the bid opening meeting, they may come with due authorizations. Specifications are as under:

- Structure Type: Box-type welcome gate with central vertical support and semi-circular top cutout
- 2. Width: May very as per requirement at the locations (75 ft to 130 ft)
- 3. Height: Minimum 20 ft from road level.
- 4. Width: 4 ft.
- 5. Pillar Size: 4 ft x 4 ft
- 6. Cutout: Central semi-circular and be fabricated using WPC (Wood Plastic Composite) material
- 7. Base Structure: Entire gate to be fabricated using steel pipe framework. Structure must withstand wind pressure up-to 100 km/hr. Base structure must be properly anchored and braced to ensure public safety. All electrical wiring (if used) must be concealed, safe and weatherproof.
- 8. Theme: Kanwar Yatra.
- 9. **Surface**: Surface to have cladding with high-quality vinyl and flex prints (UV-resistant and waterproof).
- 10. The structure/installation at all 17 locations must remain intact and fully functional, maintaining its design integrity without any wear or damage for at least one month.

The work will be executed as per given specifications and as per the following terms & conditions.

- 1. The participating firms must be registered with Trade & Taxes Department, Delhi.
